Thank you for visiting Anthurium's website.

First of all, we must apologize to you. Currently, our team does not have speakers of other languages such as English or Chinese; our staff only speaks Japanese. Thank you for your patience and understanding in this regard.

During Anthurium's chiropractic therapy, the customer and the staff work together to correct misalignment. The staff will give the customer instructions, and the customer will push and pull.

Due to the nature of our therapy, we do not accept customers who cannot understand Japanese unless they are accompanied by a Japanese speaker.

We have this policy in place to ensure the health and safety of our customers. During treatment, the staff needs to be able to communicate with the customer and ask how she is feeling. If the staff and the customer cannot communicate, the staff could injure the customer.

We hope you understand the reasoning behind our policy.

If you would like to receive therapy, please have a woman who understands Japanese accompany you.

Anthurium is for women only. Men will not be allowed to come inside the salon, even to accompany someone who is receiving therapy.

When making a reservation, please make sure to enter the contact information of the person who will be acting as the interpreter.

We will contact you to confirm your reservation.

In addition, please be aware that the presence of any of the following conditions prevent us from providing treatment, and you cannot receive therapy at our salon if you:

- Have been diagnosed with a herniated disc in the neck or lower back, or with spondylolisthesis, and have not been declared completely cured.
- Are currently pregnant, or suspect that you may be pregnant.
- Are under the age of 17. However, customers between the ages of 15 and 17 can receive therapy if they obtain the written consent of a parent or legal guardian.

Please go to the Q&A, find the question about the age limit, and download the consent form. Have the parent or legal guardian sign the consent form and bring it with you to the salon.
